Whereas, the Trust or the any
institution which will be started
under this trust would be of
Public nature and not Proprietary

whereas, the ~~executioner~~ ³ executant
is executing his deed for the moveable
property namely, namely, mayflower
school, at present situated at
Digba, Patna and since the day
of the execution of his deed the
executant ceases his right over
the said school and now the
Trust would be the Proprietor of
the said school. —————

whereas, the executant will act
as a Director and Secretary of
the Trust and the said school
will run under the control of the
members of the AKSHAY DEEP
SAMITHI (Trust). —————

whereas, now the Trust has the right
to shift the school at any other

Place where the school will
run smoothly and without any disturbance,
but the new place should be in
a suitable area. _____

Whereas the income of the said
~~school~~^{Trust} will be kept in a nationalised
bank which account will be kept
in a nationalised bank which account
will be operated jointly by the Secretary
and one of the members who
will be appointed in a meeting of
the members of the Trust.

Whereas, the institution which will
be started by the trust will be
~~more~~ ~~mainly~~ mainly governed by 4
the head of the said institution
and by laws of the said
institution and he will have the
right to collect the money and
debit in the fund of said

institution but after end of
Belton ~~the~~ balance amount will
be vested in the trust property
and hereafter trust will spend

Whereas, the income of the

Whereas, the trust will help the
poor but intelligent boys for their

education on their cost.

Whereas the Trust will call a meeting twice in a year within January to December of his members to consider the development of the trust and it is compulsory for the members to remain ~~present~~ present at the time of meeting and if any member will fail to present regularly in three consecutive meetings then his membership will be seized and remaining members will have right to appoint any suitable person in his place.

Whereas, the resolution taken by majority by that will prevail and if any member will remain absent then in presence of Sri Jai Ram Sharma another present members can take any resolution and the absent members will have no

right to deny the said resolution.
At least 6 members present in
the meeting will form the quorum.

Whereas Mr. Jai Hari Sharma
who is also a member of trust
will remain secretary and director
of the said trust and he will
keep his guidance over entire trust
and its property, but after his death
his eldest son will be secretary
and director of the trust and in
absence of his eldest son, wife of
eldest son will be secretary of
the said trust thereafter eldest
or daughter of eldest grand son
will be secretary of the said
trust likewise elder member of
the family will remain secretary
of said trust but the trust
will not be in any way treated

as personal property of the family
of Jai Ram Sharma father his
family will act only as only as
secretary and guide of the trust.

Whereas, if the family of
Jai Ram Sharma becomes unable to
act as Director and Secretary then
the remaining members will have right
to appoint any Secretary for the
trust by taking a resolution. —

Whereas the Secretary or any of
three members will have right to
call any emergent meeting any time
when they feel any emergent problem
for the benefit of the trust. —

Whereas the trustee and its
members will have right to
appoint any Principal, teaching

Staff, Clerk, Peon, etc. in
temporary basis or permanent basis
and the trust will pay ~~the~~ ^{the} salary ²
of the said staffs.

Whereas the trustee or any
member of the trust will have no
right to execute any kind of document
like sale deed, mortgage deed,
deed of will for the property of
Trust, but for the benefit of the
trust they may execute any sale
deed only and the amount of
the sale will be the property of
trust to be acquired in future.

Whereas the trustee is bound
to deal with the trust property
carefully.

Whereas in case of any litigation

for the trust probably the Secretary
will face after taking advice from
the other members also.

Whereas, the Trust will constitute
a school managing Committee and
the school managing Committee
could be formed as per rule but
Principal/headmaster would be the
all in all of the said school
but in case of other institutions
the Committee would be constituted
under the per view of the law.

completely a Public trust.

Whereas the trust will have to

Whereas, the Principal of the School or Head of any institution will be Controller of the institution and he should have control over the School management Committee and shall approve the budget / Tuition fees and annual charges etc. for the School.

Whereas, the trust will control over any expenditure i.e. on land and construction of building.
